RE: REGISTRATION OF GAUTENG METAL RECYCLERS (PTY) LTD LOCATED ON PORTION 2 OF ERF 1534, CORNER SIMON BEKKER AND LOWER BOKSBURG ROAD, EXTENSION 10, JOHANNESBURG FOR THE STORAGE AND THE SORTING, SHREDDING, GRINDING, CRUSHING, SCREENING OR BALING OF GENERAL WASTE

The above registration has reference.

The Department hereby acknowledges receipt of the storage and sorting, shredding, grinding, crushing, screening, chipping or baling of general waste registration form dated 13 December 2017 and received by the Department on 13 December 2017 and additional information received by the Department on 01 February 2018 for the registration of Gauteng Metal Recyclers (Pty) Ltd.

The waste facility is for:

The storage of general waste within an area covering **270** m³ and the sorting, shredding, grinding, crushing, screening, chipping or baling of Ferrous Steel Scrap Metal: 190 tons per month, Non Ferrous Scrap Metal Steel: 25 tons per month and Steel Shavings (also falls under Ferrous) **250 tons per month of scrap metal** in an operational area covering **2 257**m². Listed in terms of Government Notice R 921, Category C activity 1 and 6 of 29 November 2013 as amended:

Activity 1: "The storage of general waste at a facility that has the capacity to store in excess of 100m<sup>3</sup> of general waste at any one time, excluding the storage of waste in lagoons or temporary storage of such waste"

Activity 6 "The sorting, shredding, grinding, crushing, screening, chipping or baling of general waste at a facility that has an operational area in excess of 1000m² and more."

The footprint of the entire waste facility is 5 000m<sup>2</sup> in extent and is located on Portion 2 of Erf 1534, Corner Simon Bekker and Lower Boksburg Road, Extension 10, Johannesburg which falls within the jurisdiction of the City of Ekurhuleni Metropolitan Municipality.

Therefore, the site must comply with the requirements set out in the attached National Norms and Standards for Storage of General Waste, 2013 and the National Norms and Standards for the Sorting, Shredding, Grinding, Crushing, Screening or Baling of General Waste, 2017.

Please also note that the waste facility must apply to be registered as a waste as a **transfer station for the storage of waste** in the Gauteng Waste Information System (GWIS), by login on to http://www.gwis.gpg.gov.za/.

Furthermore, the Department hereby notifies **Gauteng Metal Recyclers (Pty) Ltd** that the waste facility has been registered on the Departmental database for the storage and sorting of waste. The Compliance and Enforcement Directorate of this Department may inspect the waste storage and sorting facilities at any time to verify compliance with the requirements as stipulated in terms of the National Norms and Standards for the Sorting, Shredding, Grinding, Crushing, Screening, Chipping or Baling of General Waste, 2017 and the National Norms and Standards for the Storage of Waste, 2013. Please find attached Norms and Standards for storage and sorting of general waste.

Please note that a person commits an offence if that person - contravenes or fails to comply with the Norms and Standards established in terms of the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008), as amended. Upon conviction for such an offence, a person is liable to a fine not exceeding R5 000 000.00 million or to imprisonment for a period not exceeding 5 years, or to both such fine and such imprisonment, in addition to any other penalty or award that may be imposed or made in terms of the National Environmental Management Act, 1998 as amended.

It remains **Gauteng Metal Recyclers (Pty) Ltd's** responsibility to ensure that the operation of the waste facility, remains in line with the current and applicable legislation.
